

These Terms and Conditions of Use (the “Terms of Use”) apply to the Anesthesia Consultants of Dallas, L.L.P. web site located at www.acdllp.com and to the Veritas Anesthesia, L.L.P. web sites located at www.veritasanesthesia.net and www.anesthesiadallas.com, and all associated sites linked to www.acdllp.com, www.veritasanesthesia.net and www.anesthesiadallas.com, including, but not limited to any mobile versions of these web sites, as applicable, (collectively, the “Site”).
